

#### Introduction

• The 2022 Substance Use Surveillance Report draws from publicly available provincial data and local data sources to provide an overview of the state of substance use in the KFL&A region, specifically related to the drug poisoning crisis.

 This report includes local data from Frontenac Paramedic Services, Consumption Treatment Services, the Rapid Access Addictions Medicine Program, and Kingston Police.

## Rates\* of opioid-related morbidity and mortality, Kingston, Frontenac and Lennox & Addington Public Health, 2003 – 2022






Yearly Count of Naloxone Doses Provided in PHU: Kingston, Frontenac and Lennox & Addington Health
